# **Ground Floor Suite, Chargrove House**

### Location

Chargrove House is prominently situated fronting the A46 Cheltenham to Stroud road approximately two miles south-west of Cheltenham town centre and three miles from Junction 11A of the M5 motorway. There is a single vehicular access with remote controlled entrance gates off Shurdington Road.

## **Description**

The available suite is on the ground floor and the tenant will have access to the communal areas such as reception, break out space and WCs.

Chargrove House is an imposing detached, two storey, purpose-built office building dating from the early 1990s occupying an extensive, attractively landscaped site lawned gardens with a large water feature and an extensive dedicated wildlife area with a large pond.



The suite has been refurbished and the specification includes a 10MB internet connection, LED lights, carpet floor covering and raised floor with data boxes. There is a communal reception, kitchen and WC facilities.


