107 Southgate Street

Self-contained retail unit close to Gloucester Docks. Potential for a variety of uses, subject to the necessary consent being obtained.

Location

The property occupies a prominent position on Southgate Street, a key arterial route south of Gloucester, with rear access from Norfolk Street. It is situated about half a mile from Gloucester Cross, the traditional city centre, and lies close to Gloucester Docks and Gloucester Quays, major mixed-use destinations offering residential, retail, leisure, and office accommodation.

Description

The available unit is on the ground floor of a Grade II Listed building, and the remainder of the property is residential accommodation.

The unit features a fully glazed frontage, painted plastered walls, suspended ceiling with LED lighting, laminate flooring, and perimeter trunking. It benefits from internal security shutters, along with kitchen and WC facilities.
