94 High Street, Gloucester

Highly flexible, mixed-use commercial space positioned within a busy, mixed-tenure neighbourhood.

Location

The property is situated in a high footfall area on High Street, a short distance from Gloucester City Centre and Gloucestershire Royal Hospital. This area of Gloucester is a high-density, 19th century residential and commercial area characterised by a strong community feel. 94 High Street is located adjacent to the OneStop convenience store and other occupiers in the immediate vicinity include Pablo's, Bashcutt Barbers and the Post Office.

Description

The property comprises a two-storey building of rendered brick construction under a pitched tiled roof with residential on the first floor and a self-contained retail unit at ground floor level with a shop front.

The ground floor includes the main retail area with a WC to the rear.

Rates

Planning

The ground floor has been used as a convenience store which falls within Class E of the Use Classes Order 1987. The premises also benefits from planning consent for takeaway use.

Terms

The shop is available by way of a new lease for a term to be agreed.

£7,200 per annum exclusive.

Service Charge

A charge will be levied to cover the costs associated with the upkeep and maintenance of the communal areas.

VAT

The property is not elected for VAT.

EPC
