Location

The property is located on St Aldate Street, which is on the corner of the Kings Square opposite the University of Gloucestershire's City Campus and a short walking distance from The Forum and the railway and bus stations.

Description

The property dates to the 1950s and is a 3-storey office building of brick construction under two principal flat roofs with the ground floor to be occupied in the coming weeks. There are four floors, two of which are available, of concrete frame with external brick elevations, single glazed windows and vertical blinds.

Stairs from the ground floor entrance lobby lead to the 1st floor which is an open plan office together with two private front offices, a rear private office and a separate ladies/gents WCs.

The second floor has an open office with two additional offices.

The property benefits from emulsion walls, internal security, fire alarms, air conditioning and heating, and acoustic tiled ceiling with integral category II lighting.

A kitchen and male and female WCs are provided.
