## **Hall Floor Office Suite**

An impressive hall floor office suite located within the heart of Cheltenham town centre.

#### Location

The property is situated within the centre of Cheltenham fronting the western side of Regent Street which runs parallel north to south with The Promenade. Adjacent to the offices lies the Regent Arcade which includes retailers such as Decathlon, Timpson, Tivoli Cinema and Boots Opticians.

The property is located 1½ miles east of the railway station and 3 miles east of junction 11 of the M5 Motorway.

## **Description**

The hall floor suite is approached by a shared common entrance hall. The accommodation provides Regency style office space over two rooms which interconnect with one another to give an open plan feel to the suite. The offices have painted plastered walls and ceilings with carpeted floors.

Lighting is provided by chandeliers in each room. The accommodation also benefits from gas central heating. There are shared kitchenette and WC facilities located in the rear wing of the building.
