Modern industrial unit in a prominent position on a popular business park with 7 allocated parking spaces.

Location

Neptune Business Centre is a development of industrial/warehouse units located just off Tewkesbury Road, approximately 1.5 miles to the west of the Town Centre and approx. 3 miles from Junction 10 and 11A of the M5 motorway.

Description

The property comprises an end terrace modern unit of steel portal frame construction with fully clad elevations and roof which incorporate translucent panels at regular intervals.

The unit has been finished to a good specification to include:-

- 6.8 m minimum eaves height
- Floor loading of 30 Kn/psm (600 lbs psf)
- Showroom quality glazing
- Roller shutter loading door
- 3 phase power supply with gas

The accommodation includes workshops, storage, an office and WC on the ground floor with a further office including kitchen point and storage at first floor level.

Externally, there are 7 allocated parking spaces and an area to load/unload.

The property has an EPC rating of C-60.

Terms

The unit is offered by way of a new lease for a term to be agreed.

£40,000 per annum exclusive.

A charge is levied by the Estate Landlord to cover the costs associated with the upkeep and maintenance of the common areas.

VAT

The property is elected for VAT.


