Location

The property is located close to the village of Staunton approximately 8 miles from Gloucester accessed via the A417. This is a convenient location and offers good access both to the west of Gloucester and the Motorway Network at M5 or M50.

Description

The Hawthorns Business Centre is housed in the original courtyard setting within the grounds of the 17th century farmhouse, offering modern office space, commercial property and workshops in traditional stone buildings.

There is plenty of parking onsite and additional break-out spaces, such as the walled garden, barbecue area and water-side conservation area.

The available unit is a single building but divided with a concrete wall down the middle. Each side is approx. 7000 ft2 with walls over 8 meters high. Separate lights and electric on each side of the building.

Each party to bear their own legal costs incurred in the transaction.





